**Article 7: Qualifications (for BOD Nominee as outlined in EPIC Constitution)**

1. Must be good law-abiding legal resident and Sunni Muslim who believe in the Quran and Prophet Mohammad (Peace be upon him) as the last Prophet and his teachings as the guiding principles.
2. Must be a General body member in good standing and active member of one EPIC Committee for at least one (1) year.
3. The Candidate for the President will not hold or accept any office such as Chairman, Chairman-Elect, President, President-elect, Vice President, Secretary, and Treasurer in any other Islamic/Muslim Organization.
4. Have good knowledge and understanding of Islam.
5. Be practicing Muslim known for their Islamic manners and morals in the community and organizational dealings.
6. Have adequate time, dedication and skills to be able to devote to the work in a volunteer capacity to fulfill the objectives set forth in Article 2.
7. Exhibit necessary leadership and communication skills and a lack of desire for the title, but strong desire for the work.
8. Have the ability to present ideas in a balanced and egalitarian way and maintain the ability to compromise when necessary.
